# **Golf Cart Use Reminders:**

We have more golf carts on the road, especially in the evenings and weekends, so it' a good time to remind everyone of the CCC rules and policies on use. Please see our website for the covenants and for the complete text of the golf cart policy. (If you have not seen these governing documents and policies, they are on our CCC website under "Documents" or TPAM can email you a PDF, just ask)

# Here are a few key provisions:

Gas golf carts are prohibited in the community by covenant (Article XVI), and by the separate "Golf Cart Rules" adopted by the CCCHOA in 2017. Please do not drive an ATV, gas powered golf carts or hunting buggies on our streets or conservation areas, including trails.

The operation of a golf cart is "strictly prohibited" in any conservation area except on the designated trails. The area around the lake and the lake shore are conservation areas (Leon County requires a 50 foot buffer from the normal high water mark of the lake edge) and vehicles of any type are not permitted in these areas, except for CCCHOA maintenance.

Golf carts shall not be operated within the neighborhood by persons that are less than 14 years old, unless under the supervision and control of a passenger in the golf cart holding a valid driver's license.

Golf carts may be operated during the hours between sunset and sunrise on the roadways only, provided the golf cart is using headlights and is equipped with tail lights.

Golf carts are subject to the same "rules of the road" as licensed motor vehicles.

Golf carts should always be operated to the far-right hand side of the road, allowing vehicles to pass safely on the left.

# It's Lawn Season Again!

Whether you mow your lawn yourself or have a service do this for you, you can save money and resources of you follow practices provided by the UF/IFAS guidelines that have been posted to the Centerville website under the Conservation Resources tab.

By mowing your lawn at the correct height you can reduce the amount of weeds and reduce the amount of irrigation needed. Many lawns are mowed too short which exposes the grass runners and even roots to more sun exposure and opening up the lawn for weeds to find a place to grow. Longer grass height creates a cooler turf which in turns means less evaporation and more effective growth. And taller grass allows less sunlight for weed germination. # "Conservation" is not just a name...

In Centerville Conservation Community, "Conservation" is not just the name of our community, it is the responsibility of all of us.

The conservation areas in this community are governed by the covenants (Article II, sec. 3) as well as a county conservation easement to Leon County and a qualified management easement to Apalachee Land Conservancy. Among other things, we cannot build in the conservation areas, and we cannot dump items or remove or destroy trees, shrubs, or other vegetation in the conservation areas.

Please do not mow areas that are not inside your property line. *Mowing the grass and property down to the edge of our lake shores is not permitted.* Also, cutting through of Common Areas by owners is not permitted. Please refrain from cutting paths and from mowing areas that are not part of your property. If you have a suggestion about areas in need of mowing, please contact Rich Lettera, who will consult with the Board about the matter.

#### Mind the Gates Please:

Contractors and Maintenance folks need to be using the construction entrance. The construction gate is open from 7:45 in the morning until 6 pm each evening (Except on Sundays.) Trailers and large trucks should not be coming through the gates. This increases the likelihood of damage and subjects all of us to additional repair costs.

# **Land Management:**

Our Property Manager, Rich Lettera, and our Land Management Committee Co-Chairs, Ben Bush and David Marshall have provided this update:

## The Annual Burn:

An email was sent to all owners to inform that the burn that had been planned for this month has been postponed. Due to circumstances related to COVID19, the Florida Forest Service will not issue controlled burn permits until further notice. The timing of the burn will be re-evaluated when permits become available. The annual burn is required by our governing documents which can be found on the website. We encourage everyone to take some time to review these documents for in-depth information about the conservation nature of this community, and our responsibility as owners.

The reason for the later burn this year is to allow the unwanted trees and saplings to flush out so the burn will have a better chance at killing them. The burn had been happening too early in the year in the past for this to be effective. The burn is also done as a protection measure to reduce the fuel available to feed a wild fire should that occur. Tall Timbers is our burn contractor, and with their vast knowledge of land management, we are confident that when we are able to get back on track with the burn, they will do a fantastic job.

# **Boat Launch Areas:**

As mentioned above, the area around the lake shore is a conservation area, and residents should not enter the lake from these areas and disturb this property with vehicles or boats. There is a launch area next to the dock on Lake Pisgah, which is the appropriate place to put in boats, canoes and other permitted watercraft. There is also a stable area to put canoes, etc. in on the west end of Amber Lake near the pavilion. Please do not use any other areas around the edges of the lakes to put in boats or other recreational watercraft,
